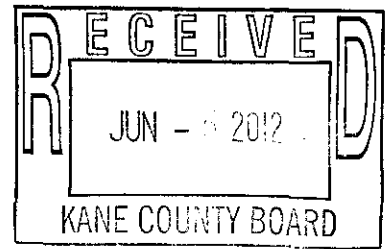

**CONTRACT FOR VETERINARIAN ADMINISTRATOR
KANE COUNTY ANIMAL CONTROL
AND
Jane L. Davis**

The Kane County Animal Control Department, 4060 Keslinger Road, Geneva, Illinois 60134 hereinafter referred to as "DEPARTMENT" and Jane L. Davis, hereinafter referred to as "CONTRACTOR", agree as follows:

1. Documentation

- 1.1 The Contractor provides the following documents:
 - A. Copy of Veterinarian License
 - B. Certificate of Insurance

2. Services:

- 2.1 Serve as the emergency veterinarian.
- 2.2 Will efficiently administer the policies and technical assistance of the countywide rabies control program in conformity with the State of Illinois Animal Control Act and in cooperation with the police, veterinary community, animal owners, and general public.
- 2.3 Have the ability to provide public service in relation to veterinary and animal control practice.
- 2.4 Responsible for communicating verbally or in writing with Kane County Health Department Press releases.
- 2.5 Maintain rapport and working arrangements with other practicing veterinarians in the County so that continuous coverage of animal control is provided.
- 2.6 Provide technical assistance to staff when needed.
- 2.7 Attend Public Health Committee meetings when necessary.
- 2.8 Responsible for insuring that all county animal control ordinances are complied with.

3. Term:

- 3.1 The period of this agreement is May 27, 2012 through May 27, 2013. However, it may be terminated at any time during this period by either party upon giving written notice to the other party thirty (30) calendar days in advance of the actual termination date. Upon termination, CONTRACTOR shall be paid for work satisfactorily completed prior to the date of termination.

4. Compensation:

- 4.1 The total contract payment not to exceed \$29,999. The services will be billed at the rate \$2,000 monthly to be expended from account

The parties to this agreement by their signature acknowledge they have read and understand the Contract Documents and this Agreement and intend to be bound by their terms:
