

### RESOLUTION NO. <u>11 - 140</u>

### APPROVING LOCAL AGENCY AGREEMENT FOR THE JURISDICTIONAL TRANSFER OF MANNING ROAD FROM THE COUNTY OF KANE TO THE VILLAGE OF HUNTLEY

WHEREAS, the Illinois Constitution of 1970, Article VII, Section 10 and the Illinois Compiled Statutes (5 ILCS 220/1 *et seq.*) authorizes the Village of Huntley (Village), the County of Kane (County) and the State of Illinois, acting through its Department of Transportation (IDOT) to cooperate in the performance of their respective duties and responsibilities by contract and other agreements; and

WHEREAS, the County has exclusive jurisdiction over County Highway No. 52 (also known as Manning Road) and desires to transfer exclusive jurisdiction of Manning Road from its intersection with Illinois Route 47 southerly to its intersection with Big Timber Road in its entirety (hereinafter Manning Road) to the Village under the terms and conditions as set forth in the Local Agency Agreement for Jurisdictional Transfer (a copy of which is on file with the Kane County Clerk); and

WHEREAS, the Village desires to accept exclusive jurisdiction of Manning Road as aforesaid in its entirety pursuant to the aforementioned agreement.

NOW, THEREFORE BE IT RESOLVED by the Kane County Board that the County of Kane transfer in its entirety exclusive jurisdiction of Kane County Highway No. 52, also known as Manning Road from its intersection with Illinois Route 47 southerly to its intersection with Big Timber Road to the Village of Huntley and that the County Board Chairman is authorized to execute a jurisdictional transfer agreement and any other documents necessary to accomplish the same; said jurisdictional transfer shall be effective in accordance with the Local Agency Agreement for Jurisdictional Transfer executed by the County of Kane, the Village of Huntley and the Illinois Department of Transportation.

BE IT FURTHER RESOLVED that with Illinois Department of Transportation approval, the above location, identified as County Highway No. 52 (Manning Road) from its intersection with Illinois Route 47 southerly to its intersection with Big Timber Road, be permanently deleted from the highway system of Kane County.

BE IT FURTHER RESOLVED, that the County Clerk is hereby directed to transmit certified copies of this Resolution to the State through the Illinois Department of Transportation's Regional Engineer's Office at Schaumburg, Illinois.
